Japan - one year applying the 1980 Convention

- Convention entered in force on April 1, 2014 in Japan
 - Japan CA received 113 applications
 - 69 requests for assistance in visitation or contact
 - 44 requests for assistance in return
- Children returned
 - Children abducted to Japan were returned to their habitual residence in 3 cases (France, Germany, Canada)
 - Children removed from Japan were returned in 4 cases
- Visitation/contact with the child
 - Japan CA facilitated the contact with the removed children: assistance with cross border visit of the removed children, contact through video chats

Ongoing activities regarding the 1980 Convention

- Working Group to develop a Guide to Good Practice on the Article 13(1)(b) ("grave risk exception")
- Revision of INCASTAT, the database of statistics on international child abduction
- Update and maintenance of INCADAT, the database of case-law on the 1980 Convention
 - Among others, enriching of the database with LatAm countries jurisprudence
 - Improvement of the INCADAT website
- Meeting of the International Hague Network of Judges (November 2015, Hong-Kong)

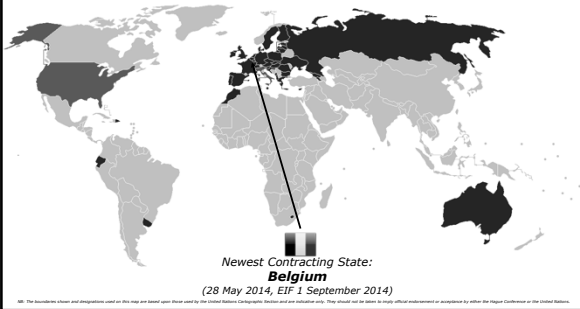
Working party on Mediation

- Achievements and ongoing activities of the Working Party on Mediation:
 - Development of "Principles for the establishment of mediation structures in the context of the Malta Process"
 - International seminar of the WP on mediation held in The Hague in April 2014 ("Islamic Legal Perspectives on Cross-Border Family Disputes Involving Children")
 - Regional seminar of the WP on mediation in Southeast Asia held in Nov. 2014
 - Research study on PIL in the context of Islamic Law conducted by Prof. Anver Emon (University of Toronto, Faculty of Law) and Prof. Urfan Khaliq (Cardiff Law School)
- "Malta IV" Conference (*tentatively scheduled in May 2016*)

Convention of 19 October 1996 on Jurisdiction, Applicable Law, Recognition, Enforcement and Co-operation in Respect of Parental Responsibility and Measures for the Protection of Children

Ongoing activities regarding the 1996 Convention

- Experts' Group on Cross-border recognition and enforcement of agreements, including those resulting from mediation
 - 2013: First meeting of the Experts' Group concluding that there is a need to develop a binding or non-binding instrument
 - Next steps:
 - circulation of a questionnaire
 - organisation of another meeting of the Experts' Group (November 2015)
- Co-organisation with ISS of a conference on "Cross-border child protection: Legal and social perspectives" (October 2015, Geneva)
