Andrew Davies is admitted to the Supreme Court of Western Australia. He is nationally accredited as a Family Law Specialist, a mediator and Family Dispute Resolution Practitioner approved by the Attorney General's Department. Andrew has presented



papers and lectures at state, national and international levels. He is an executive member of the board of the IAFL (Asia-Pacific Chapter); Chair of the Family Law and Family Rights Section of The Law Association for Asia and the Pacific ("LAWASIA"); former Chair of Australian Institute of Family Law Arbitrators and Mediators ("AIFLAM"); and the former Western Australia editor of Lexis Nexis Family Law. Andrew practises as a principal of O'Sullivan Davies, and is rated by Doyles as a preeminent family lawyer.

Poonam Mirchandani is a Singaporean advocate and solicitor, specialising in cross-border family law matters involving child custody issues, relocation applications, international child abduction cases, etc. She has specialised knowledge of international child



abduction, and recently appeared before Singapore's apex court in two Hague Convention cases. Poonam is an accredited Family Mediator with the Singapore Mediation Centre ("SMC"), an accredited Cross-Border Family Mediator, and a collaborative family practitioner. She is also a Parenting Coordinator and a Child Representative appointed by the Family Justice Courts Singapore. She is part of the Family Law Practice Committee, Singapore Law Society, and the Vice-President of the IAFL (Asia-Pacific Chapter).

Nigel Nicholls is a solicitor of both New South Wales ("NSW") and England, having been appointed a Registrar and Mediator of the Family Court, before returning to private practice. In 2004, Nigel practised in England with Taylor Vinters Solicitors in Cambridge. Nigel is a member of the International



Academy of Collaborative Practice, and he established the Central Sydney Collaborative Forum. He is also a member of Collaborative Practice (NSW) and the Australian Association of Collaborative Professionals. A Fellow of IAFL, he became the inaugural President of the Asia-Pacific Chapter in 2017.

Max Meyer is a member of the New South Wales Law Society and the Family Law Section of the Law Council of Australia, and an accredited Family Law Specialist. He is the first elected President of the newly formed Asia-Pacific Chapter of the IAFL.



He has contributed chapters to Family Law Jurisdictional *Comparisons*, published by Thomson Reuters, and *Family* Law and Practice in Hong Kong (3rd Edition), published by Sweet & Maxwell. He has acted in international financial disputes on marital breakdown, and other disputes for high-profile and high-net-worth professional and business clients.

Foo Yet Ngo is admitted to the English Bar of England and Wales, and to the Malaysian Bar. She has been practising principally in the area of family law in her own law firm, Messrs Y. N. Foo & Partners since 1996. She was on the joint Bar Council and



Attorney General's Chambers working committee to reform the Malaysian Law Reform (Marriage and Divorce) Act 1976, and has appeared as amicus curiae for the Malaysian Bar on a number of landmark Malaysian family law cases. She was the first Malaysian IAFL Fellow, having acted in several international divorce and cross-jurisdictional disputes and given expert opinion on Malaysian law to the Family Court in Melbourne, several English Family Courts, and the High Court of Justice, Northern Ireland.

Kiran Dhaliwal was admitted to the Malaysian Bar in 1991. Since joining Messrs Y. N. Foo & Partners in 1996, where she is now a partner, she has practised predominantly in the area of matrimonial law, including cross-border



disputes. Kiran has been involved with working with women in need of protection through Women's Aid Organisation ("WAO"), as well as with All Women's Action Society ("AWAM"). Kiran and Foo Yet Ngo co-authored the Malaysian chapter in Family Law: A Global Guide from Practical Law, and the International Relocation of Children: A Global Guide from Practical Law. Kiran is also a mediator registered with the Malaysian Mediation Centre of the Bar Council.
