#### INTRODUCTION

The International Academy of Family Lawyers (IAFL) is a worldwide association of practicing international lawyers who are recognized by their peers as the most experienced and skilled family law specialists in their respective countries. IAFL was formed in 1986 to improve the practice of law and the administration of justice in the areas of family law and divorce throughout the world and now has a global network of over 1,030 fellows in more than 75 countries.

IAFL has a unique position globally, not only does it support the education of lawyers throughout the world and facilitate opportunities for them to grow their professional networks, but we also have a place in giving back to the worldwide community, and supporting vulnerable children and families.

IAFL is the only not-for-profit organization with Observer status at the Hague Conference on the proposed parentage and surrogacy convention, and we also have observer status on all of the main family conventions. In the last two years IAFL has supported work on the effective operation of these international conventions designed to prevent and address child abduction, support best practices in inter-country adoption and the protection of children internationally, including facilitating support of children financially. In 2023, IAFL also supported specialist family law training of the judiciary in Kenya and Zambia.

#### IAFL MEETINGS

IAFL Meetings are an integral part of our annual activity. Currently the IAFL organizes four main meetings per year which are open to Fellows and Lawyer Guests. The Annual Meeting of the IAFL is always held in September, and the Chapter meetings rotate between February, May and December.

In 2024 four meetings were held in Brisbane, Boston, Seattle and Paris which attracted a total of 1,066 attendees and 125 lawyer guests. IAFL Meetings include a substantial education program where the theory and practical application of international family law is discussed and debated at the highest level by some of the most experienced and skilled family law specialists from all over the world, and an extensive social program which provides numerous opportunities for networking in a variety of different settings.
