# Serving children with distinction and dedication; Lessons Learnt: Steps ahead

#### **History**

The CRADLE was founded in 1997 to provide legal support to children in contact with the justice system. A formal launch of the organization was undertaken on the 7<sup>th</sup> of December 1997 during the human rights week to show a deliberate choice for a rights-based approach in its work. The launch was presided over by Justice Arline Pacht of the USA, then President of the International Women Judges Association, and Hon. Shem Ochuodho, then MP, Rangwe Constituency.

The CRADLE has since undertaken trailblazing and transformative work for children nationally, regionally, and internationally. The key milestones:

#### Access to Justice Program

The CRADLE has impacted over 20 million children through impact litigation and represented over 20,000 children directly in court through its in-house lawyers and a pool of *pro bono* lawyers under the *Pro Bono* Scheme. The CRADLE also ran Child Help Desks in courts and a Diversion Program.

#### **Impact Litigation Cases:**

#### Children Born out of Wedlock

The CRADLE represented a 2-year-old against the Attorney General in a groundbreaking case challenging the Children Act for discriminating against children born out of wedlock. The decision wad not favorable, but the organization lobbied for the inclusion of the provision in the Constitution.

#### Access to Counsel for child offenders

The CRADLE brought a case in Bungoma Law Courts challenging a decision against a young boy who had been sentenced for a criminal act yet he had no legal representation. The court ruled in the organization's favour and noted that children in the justice system must be afforded legal counsel.

# Child offenders subject to special procedural treatment

A 12-year-old girl, S.A, was charged with murder after she was alleged to have killed a child she was babysitting. The courts failed to follow the procedure in relation to child offenders. The CRADLE challenged this matter successfully in court and SA was acquitted.

#### Discrimination of children with disabilities in the media

The CRADLE brought a case against the Nation Media Group for allegedly discriminating against children with disabilities by not offering disability-friendly platforms for broadcast. The High Court ruled in favour of The CRADLE, but the Nation media group appealed, and the matter is still pending in court.

#### Inter sex Children, (Baby x Case)

The CRADLE brought a case against the Attorney General of Kenya of an intersex child dubbed the "Baby X case." The case sought to ensure that government agencies, including justice institutions, offer intersex-friendly facilities for children including separate cells and separate bathrooms. The Court made positive declaratory orders.

#### When Does Life begin?

The CRADLE brought a case before the enactment of the 2010 Constitution that inadvertently had an impact on when life begins. A man who had made the house manager pregnant refused to pay for pre-natal care for her. The matter was subsequently settled out of court, and the issue of when life begins was eventually decided by Kenyans in the 2010 Constitution.

#### **Acquiescence in Cases of Sexual Abuse**

The CRADLE successfully sued the government for compensation in a case of sexual abuse against a child where the organization claimed that the government should be held responsible for failing to take measures to protect a child from abuse in a government institution.

#### P3 and Post Rape Care Form Case

In this case, the police had refused to give a P3 and Post Rape Care (PRC) Forms to a victim of child sexual abuse thus compromising the case. The child awarded damages. The courts also made a ruling that these forms must be made available expeditiously to victims of sexual violence.

# **Policy and Legislative Impact**

The CRADLE has, on its own initiative and in partnership with other agencies, undertaken work that has changed the legislative landscape for children in Kenya and beyond. The work has entailed the following:

#### The 2010 Constitution

The CRADLE can correctly be described as one of the founding organizations of the 2010 Constitution, as it was one of only two child-focused organizations represented in the process. The CRADLE was represented by the then Executive Director, Millie Odhiambo, who was a delegate and served under the Bill of Rights Committee. The footprints of involvement of the organization in the process, is evident in the Constitution and include the following: access to justice; children born out of wedlock; removal of procedural technicalities under Article 22. that enables the indigent to access justice; provisions on *locus standi*, and *amicus curiae* enabling organizations like The CRADLE to represent children: outlawing of child marriages; soci-economic rights; victim protection; Protection of children against trafficking; amongst others.

# Technical Support and Advisory Role on Legislation and Policy to the Government and UN agencies

The CRADLE has been engaged by the government of Kenya in several policy and legislative initiatives as follows:

# Mainstreaming in Action

This program entailed mainstreaming rights in seven Government of Kenya ministries

# Governance, Justice, Law and Order Sector Reform Program, GJLOs

The GJLOs program was a reform program housed by the then Ministry of Justice and Constitutional Affairs, (MOJCA). The CRADLE was the chair of the CSOs Caucus to GJLOs and a member of the Technical Coordinating Committee, the TCC.

#### Task Force on the Implementation of the Sexual Offences Act

The Task Force was responsible for the effective implementation and administration of the Act.

#### Counter Trafficking in Persons Advisory Committee

The CRADLE served as the first chairperson and advocated successfully for the establishment of a Fund for victims of trafficking under the law.

#### **Advisory Committee on Treaty Obligations**

Through this Advisory Committee, awareness was raised on various treaties ratified by Kenya;

#### UN Study on Violence against Children

The CRADLE took a leading role in the drafting of the Kenya report on violence against children under the leadership of UNICEF. The CRADLE also represented Africa CSOs in the UN study on VAC through the NGO Advisory group to the study.

#### **UN Individual Complaint Mechanism**

.The CRADLE undertook pioneering work in promoting this mechanism in Kenya and in seeking to get Kenya to ratify the protocol.

#### The Intersex Person's Implementation Coordination Committee, IPICC Committee

The Committee was mandated to support the government in implementing the recommendations outlined in the Intersex Persons' Task Force report. The CRADLE served in this Committee to ensure that issues dealing with Intersex children are covered.

#### National Council on the Administration of Justice, NCAJ

The NCAJ seeks to "strengthen and entrench a well-coordinated justice sector that will guarantee access to justice for Kenyans and contribute to social justice and transformation. The CRADLE is a member of the Technical Committee of this Task Force and also a Member of the Special Task Force for Children under the same umbrella.

# The National Committee on Criminal Justice Reforms, NCCJR

The CRADLE served as a member of the Committee working on criminal justice reforms relating to children.

#### **NALEAP**

The CRADLE was part of the agencies that worked towards the setting up of a National Legal Aid Scheme. This resulted in the setting up of the National Legal Aid Service as a state agency under the Legal Aid Act, 2016.

#### One Stop Gender-Based Violence Recovery Centre at Kenyatta National Hospital

The CRADLE was part of a network that lobbied for the establishment of this facility to enhance access to justice for victims of SGBV.

#### **Special Prosecutors on Sexual Offences**

The CRADLE lobbied the office of the Attorney General for the gazettement of private lawyers as special prosecutors in cases of sexual violence, especially sexual violence against children. This was approved and all the then *pro bono* lawyers of The CRADLE were gazetted amongst the first batch of special prosecutors on sexual violence.

#### **Diversion Program**

This program entailed working with the judiciary to ensure that many children in conflict with the law did not end up in the justice system but that alternative justice systems was sought outside the court process. This has now been entrenched in the Children Act.

# Child Rights Education and Awareness

#### **About the Program**

This program has, over the years, focused on building the capacity of children and the general public as claim-holders and also government officials as duty-bearers to enable them better protect children.

## The Intergenerational School-Based Programs

#### The Girls SHALL programs

This Girls Safe Horizon and Letter Link is a twin mentorhip Program and provides a safe space for girls to discuss, share and learn about issues in a safe non-judgmental space.

# The SHELF Program

The Safe Horizon, Education and Leadership, SHELF Program is a sister Program to the Girls SHALL Program and focuses on high school and university students, equipping them with skills to better protect and claim their rights.

#### Media Awareness Program

This program employs the media including social media to create awareness on child rights.

#### Paralegal Program

The organization has run a paralegal program over the years through which over one thousand paralegals have been trained.

#### **Community Advocacy Program**

The organization has undertaken several advocacy programs in different parts of the country on various issues, on child rights.

#### Child Internet Safety, Security, and Awareness Program

This program was done in partnership with the Communication Commission of Kenya, (CCK), now the Communication Authority of Kenya. To protect children online.

# Research, Monitoring, and Documentation

The program aims to inform policy and legislative change for the enhanced protection of the rights of the child. It has done this work through various initiatives as follows:

#### **Treaty Bodies Monitoring Project**

The CRADLE has monitored the implementation of international and regional treaties Kenya has ratified. The CRADLE also attained Observer Status with the African Commission on Human and Peoples' Rights The CRADLE was the founding chairperson of the CSO Forum on African Commission. It has also participated frequently in the CSW and sent child representatives to the UNGA Special Session on Children in New York and in other similar initiatives regionally and international.

#### The Case Trends Monitor

An annual monitor of cases on child rights, the Case Trends Monitor, is undertaken annually to inform policy and law.

#### Child Rights IEC Materials

The CRADLE produced several child-friendly IEC materials as follows:

- Letter Link Magazine; This is a child-friendly magazine targeting children in primary schools.
- Handbooks for children: This is mainly for children in high school and in colleges.
- Training Manuals: For various professionals on child rights.
- Guides The guides are reference materials on various topics such as 'Trauma'; '

#### Handbooks

Juvenile Justice Quarterlies: These are quarterly productions on cases relating to child justice from around the world.

Juvenile Justice Journal: This is an annual in-depth study on child rights issues for lawyers.

**Policy Briefs and Papers**: These are for MPs for legislative action.

Research on topical or emerging issues on child rights: This is mainly cutting-edge research on emerging issues such as child safety online and trafficking in persons.


